Legislation that defines intellectual property rights establishes a monopoly of authors on certain forms of use of the results of their intellectual, creative activity, which can thus be used by others, but only with the permission of the former.

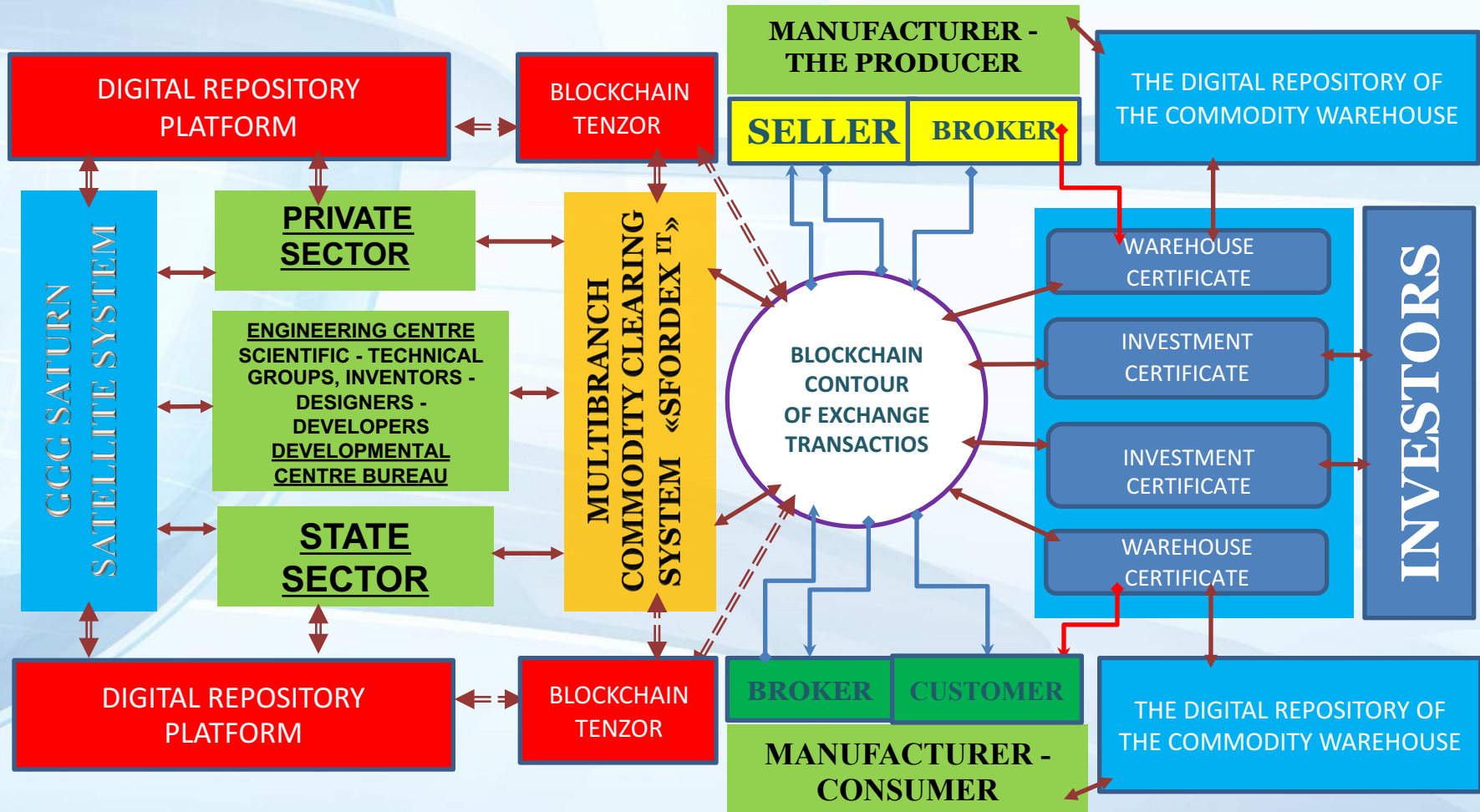

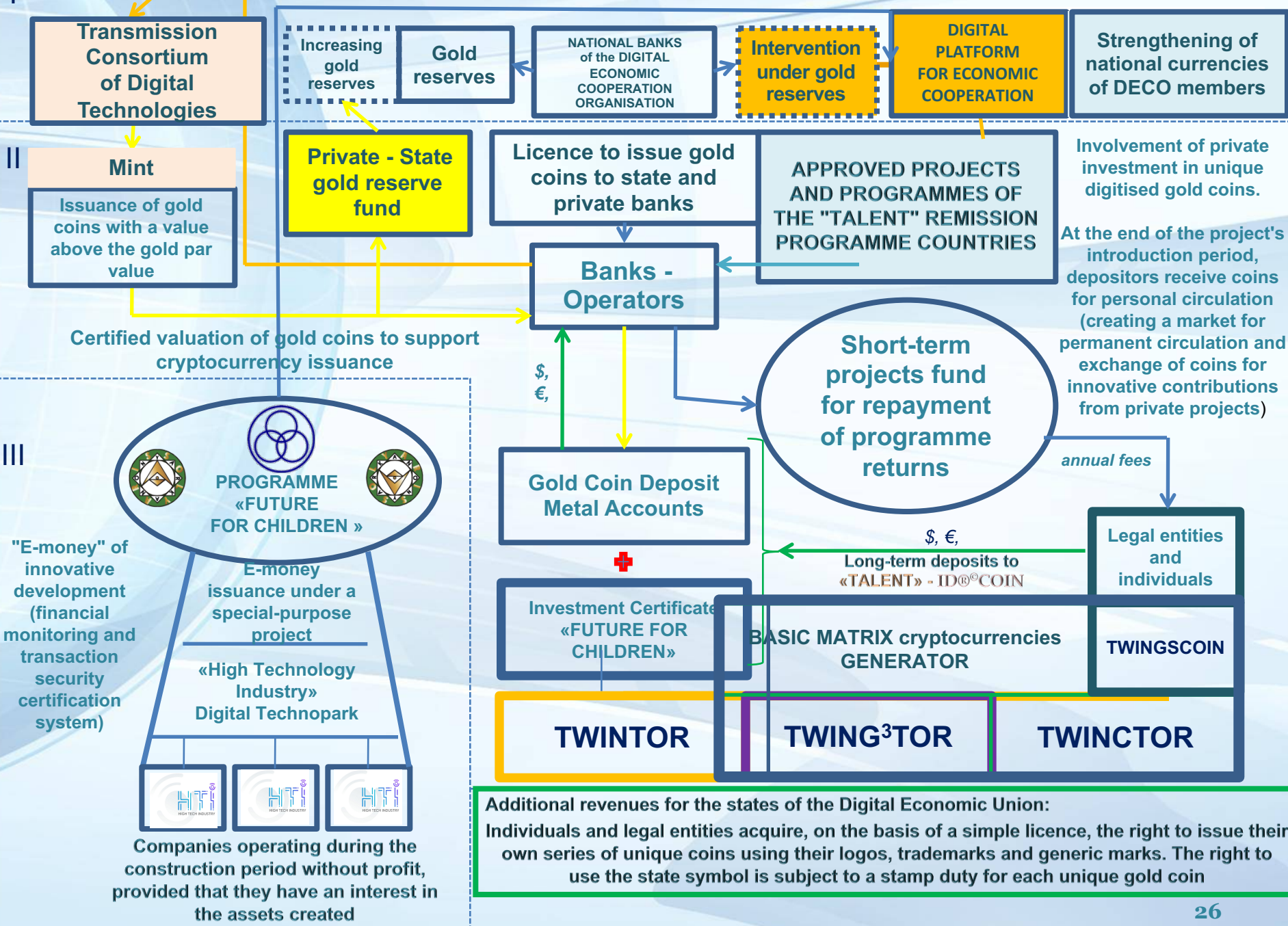

The identification of the participants and the registration of transactions is carried out using the number of an identity card or a company registration number with a tax identification code, as well as other parameters provided for in our **Basic Cross-platform «GGG SATURN SATELLITE SYSTEM+»**, However, account holders may be able to post additional information, for all activities, including the nomenclature of goods and services and their prices that they offer for sale/retail, which will allow to digitise the process from the initial production cycle of goods and services to the final sale with payment directly on the platform.

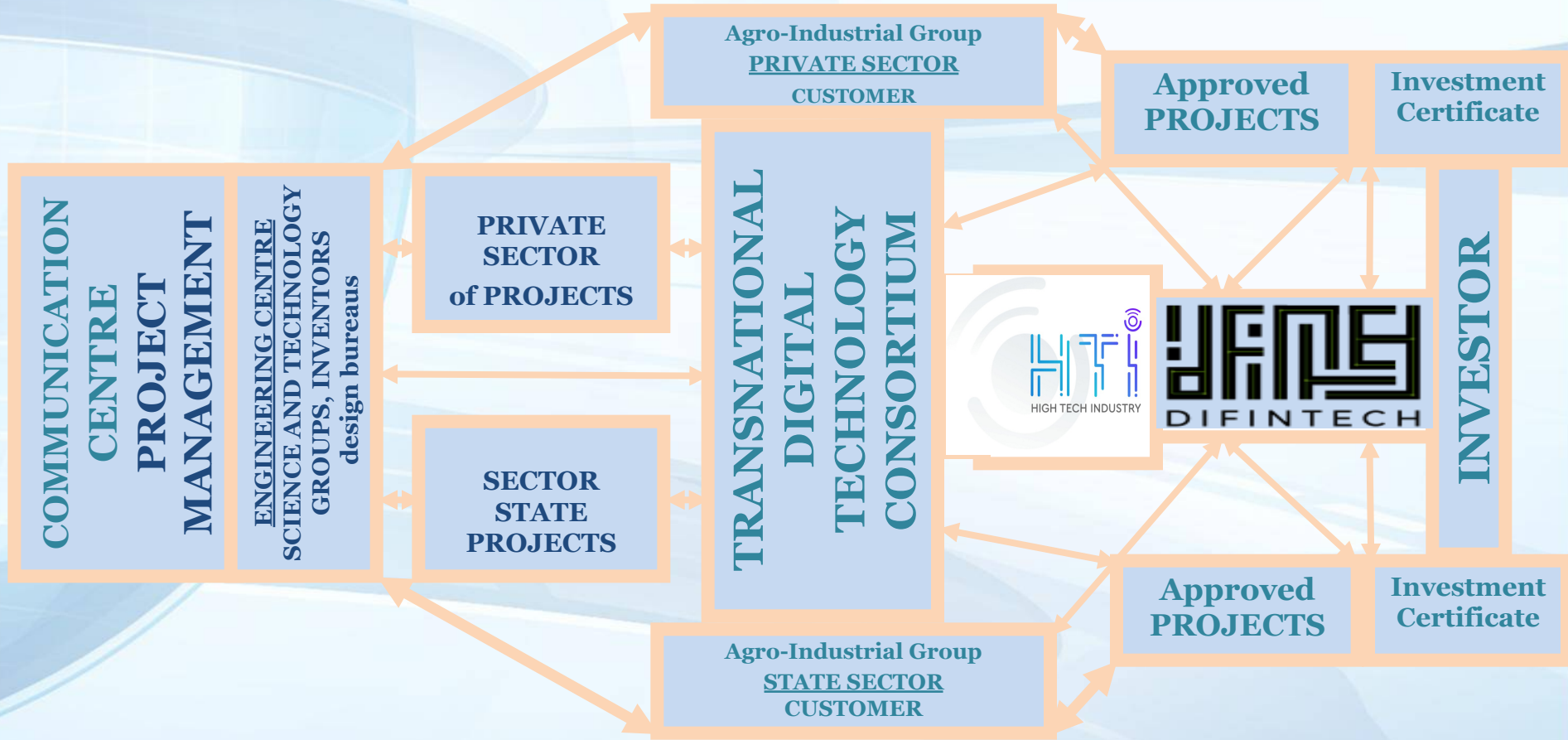
